# LAMBENA LAS ABF

Purina LAMBENA LAS ABF is highly fortified with essential minerals and vitamins. LAMBENA LAS ABF is designed to be fed from day one to market weight to ensure rapid weight gain and excellent carcass quality. LAMBENA LAS ABF can be mixed with on-farm whole grains to achieve the desired final finish.

Purina LAMBENA LAS ABF feeding guidelines:  
Offer free-choice with roughage from day 1 to 8 weeks old.  
From 8 to 11 weeks of age mix 2/3 Lambena ration with 1/3 grain. Feed free-choice with 0.5 kg. of roughage /head/day.  
From 11 weeks of age mix equal parts Lambena and grain.  
Feed free-choice with .5 kg. roughage/head/day.

Do not allow horses or other equines access to this medicated feed as ingestion may be fatal.

## OPTIMIZE YOUR LAMB'S DIET

Clardigan Feed Services recommends you follow these management practices:

When changing roughages or grain rations, do so gradually. Allow 7 to 10 days for animals to adjust.

Offer high quality roughage and salt free choice at all times.

Provide a source of clean, fresh water at all times.

Do not allow fine material to accumulate in feeders.

Provide adequate bunk space for each animal. Bunks should be protected and well managed to prevent feed from becoming wet or mouldy.

When feeding from self-feeder, adjust feeder to minimize quantity of feed accumulating in trough.

Feed is perishable: Store in a dry, well-ventilated area protected from rodents and insects. Do not feed mouldy or insect infested feed to animals as it may cause illness, abortion or death.

Lambs should be vaccinated against enterotoxaemia.

Consult your veterinarian for recommended health programs for your local area. This includes internal and external parasites.

These recommendations are intended as a guide. They should be adjusted to variables of management, environment and individual needs. If necessary, consult your local Purina Dealer.
